



3. Distribution of Editorial Board Members




CDT has 72 Editorial Board Members from 23 countries. Among them, 30% from USA, 10% from Germany and 10% from Australia.

4. Number of Submitted Articles and Published Articles (results by year)



5. Types of Articles Published in 2019




In 2019, CDT has published

6. International Diversity of Corresponding Authors in 2019




Corresponding authors of 120 articles published in 2019 come from 27 countries with 26% of them from USA.

7. Citations of CDT (results by year)




Number of total citation has significantly increased to 3,350 in 2019.

8. Monthly Retrievals in PubMed in 2019




9. Page Views of the Website (2019)







"Art and Medicine" column, where artists submit their art works related to medicine, together with a short text telling the story of the work. Some of these art works are used as cover images.


