The ARRIVE Essential 10

These items are the basic minimum to include in a manuscript. Without this information, readers and reviewers cannot assess the reliability of the findings.

Study design	1 For each experiment, provide brief details of study design including: a. The groups being compared, including control groups. Sample size	2 a. Specify the exact number of experimental units allocated to each group, and the total number in each experiment. Also indicate the total number of animals used. b. Inclusion and exclusion criteria	3 a. Describe any criteria used for including and excluding animals (or experimental units) during the experiment, and data points during the analysis.
