Responds to the reviewer's comments:

Comment 1: I recommend changing the word "first" to "former" in line 19.

Comment 2: I recommend removing the word "the" from "case of the simultaneous" in line 21.

Reply 2: I have removed the word "the" from "case of the simultaneous", and thank you for the suggestion.

Comment 3: I do not understand what you mean by "protopathy caused by CAH" in line 22. Could you clarify?

Reply 3: Chronic mildly to moderately elevated androgens or intermittent hyperandrogenemia may trigger the activation of the hypothalamic-pituitary axis (HPA) leading to central precocious puberty (CPP) which is frequently seen in the patients of CAH. In addition, thank you for the suggestion, I have changed the phrase "protopathy caused by CAH" to "protopathy of CAH" so as to be understood easier.

Changes in the text: line 6 page 2

Comment 4: In line 42 you did not hyphenate "simple virilizing" but in line 43 you hyphenated them. Please choose to either hyphenate or do not hyphenate them.

Reply 4: I have changed "simple virilizing" to "simple-virilizing", and thank you for the suggestion.

Comment 5: In line 44, you may want to consider replacing the word short with compromised.
