## **Review Comments**

Comment 1: In this paper the authors provide an overview of the potential of US in the assessment and management of upper extremity lymphedema. The authors detail different use cases and provide some example images. There are minor spelling/grammar errors, please check manuscript. For example, line 285 "intraopertaive" should be "intraoperative", line 310: "waist" should be "waste", and the very last sentence (lines 332-334) is incomplete and not grammatically correct. The review is comprehensive and touches on key advantages of ultrasound over other imaging modalities, mainly lymphoscintigraphy and ICG. The figures are nice but might be useful to label what is vein and what is a lymphatic channel. it may be obvious to those who use US but will not be for those who are not.

Reply 1: We thank the Reviewer for their comments. The paper has since been cleaned of spelling/grammatical errors and additional stylistic adjustments were made. Of note, we did not include figures in our original submission.

Comment 2: Generally, references are lacking throughout the manuscript. The material then appears to be the authors opinions.
