in gastrointestinal oncology epidemiology derived from periodic or ad hoc surveillance; (6) Technical Reports: Originally devised techniques for gastrointestinal oncology diagnosis or treatment; (7) Short Communications: Small scale studies that include important new information; (8) Letters to the Editor: Letters commenting on articles published previously in the Journal or expressing views on topics relevant to GI oncology.

JGO will be published quarterly by Pioneer Bioscience Publishing Company; all articles will be submitted electronically. The entire submission and review process will be managed through Editorial Manager, an electronic system utilized to manage over 100 various journals. We are confident that authors and reviewers using this system of manuscript submission and review will find it user-friendly and straightforward.

Our goal is to provide the reader of JGO with a new, well-constructed, informative, and educational journal.
