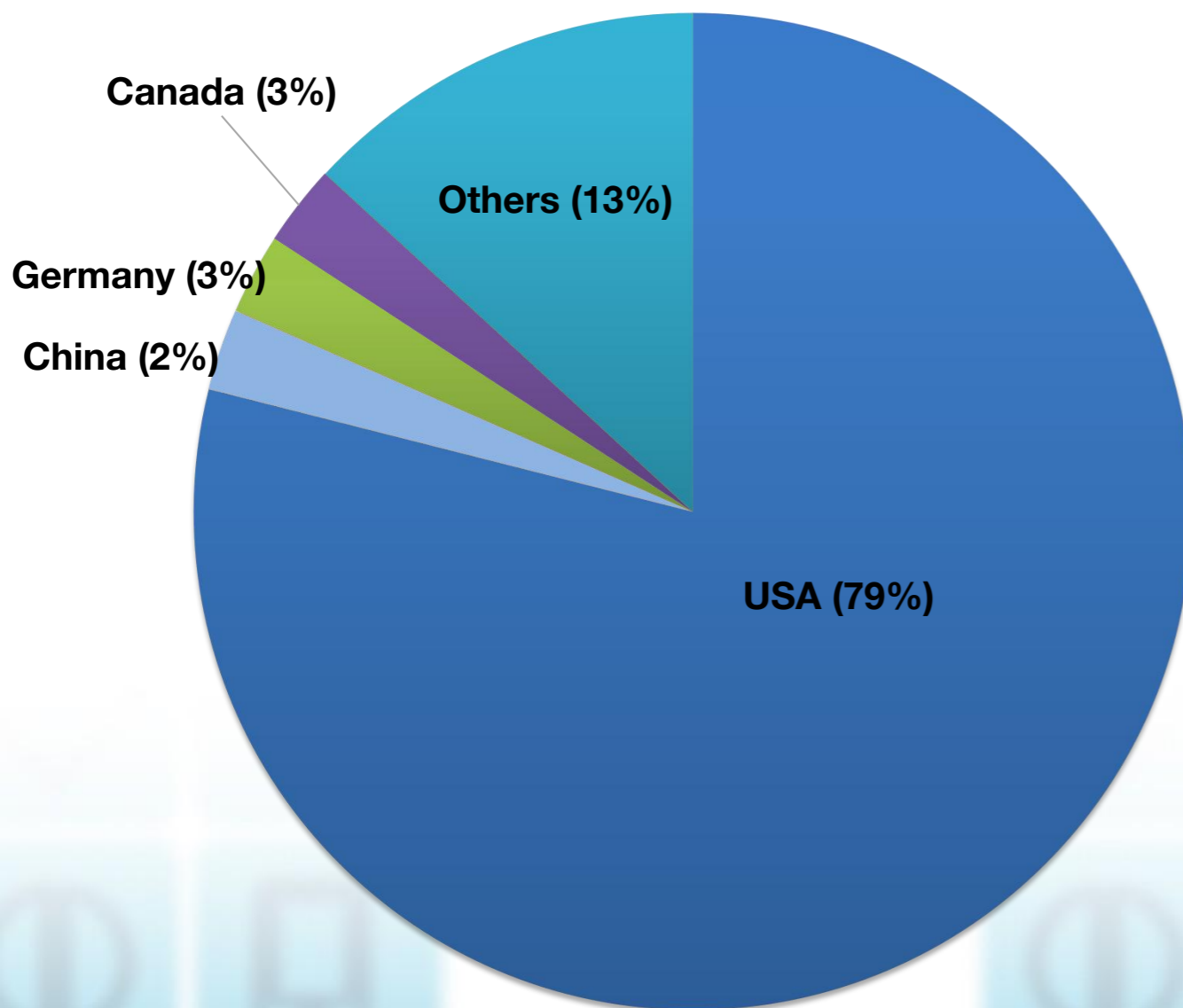

## 3. Distribution of Editorial Board Members



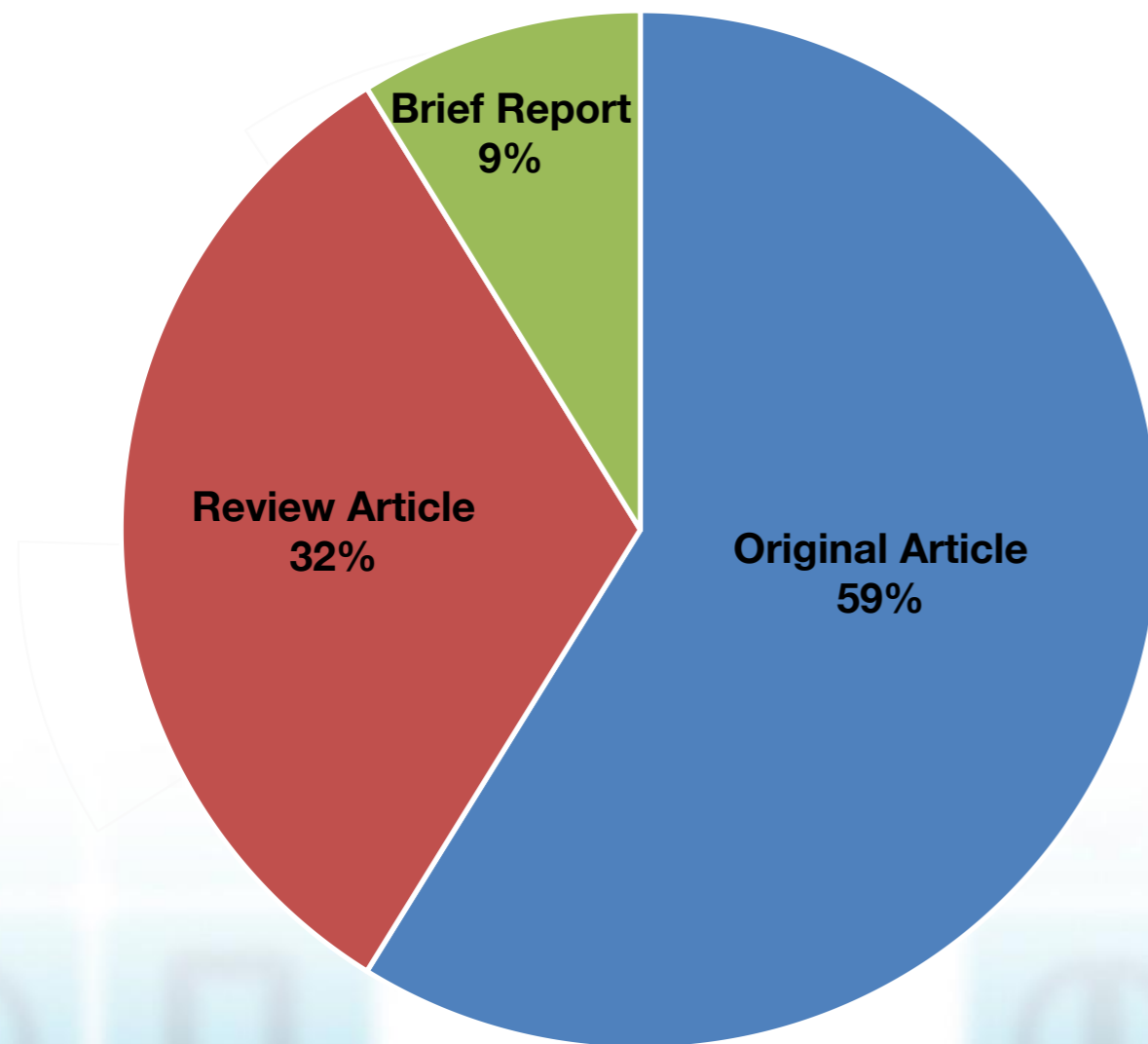
Altogether **38** members from **9** countries:

From March 10, 2015 to December 31, 2024, *mHealth* has published **443** articles in total.

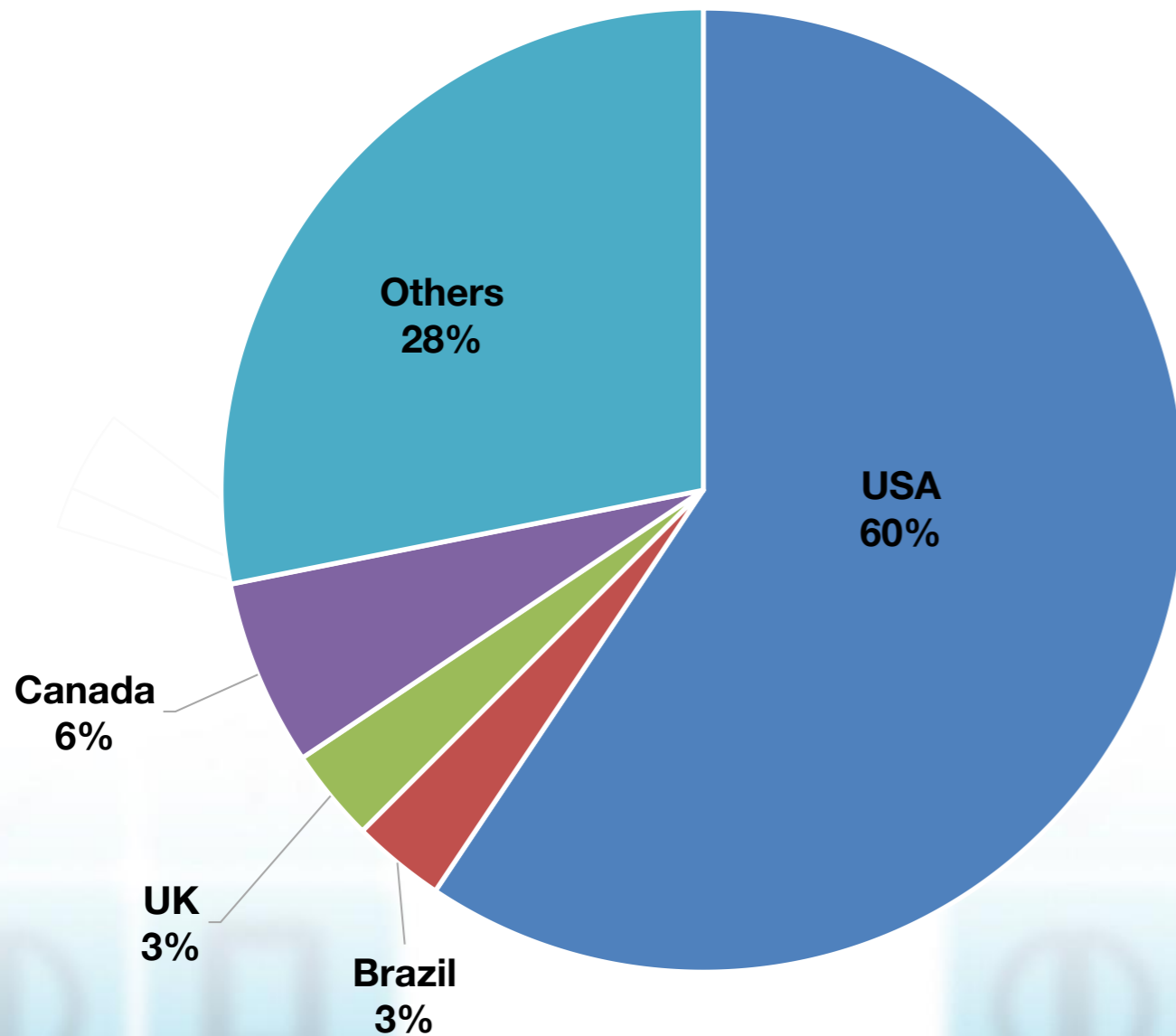
In 2024, mHealth published **34** articles:

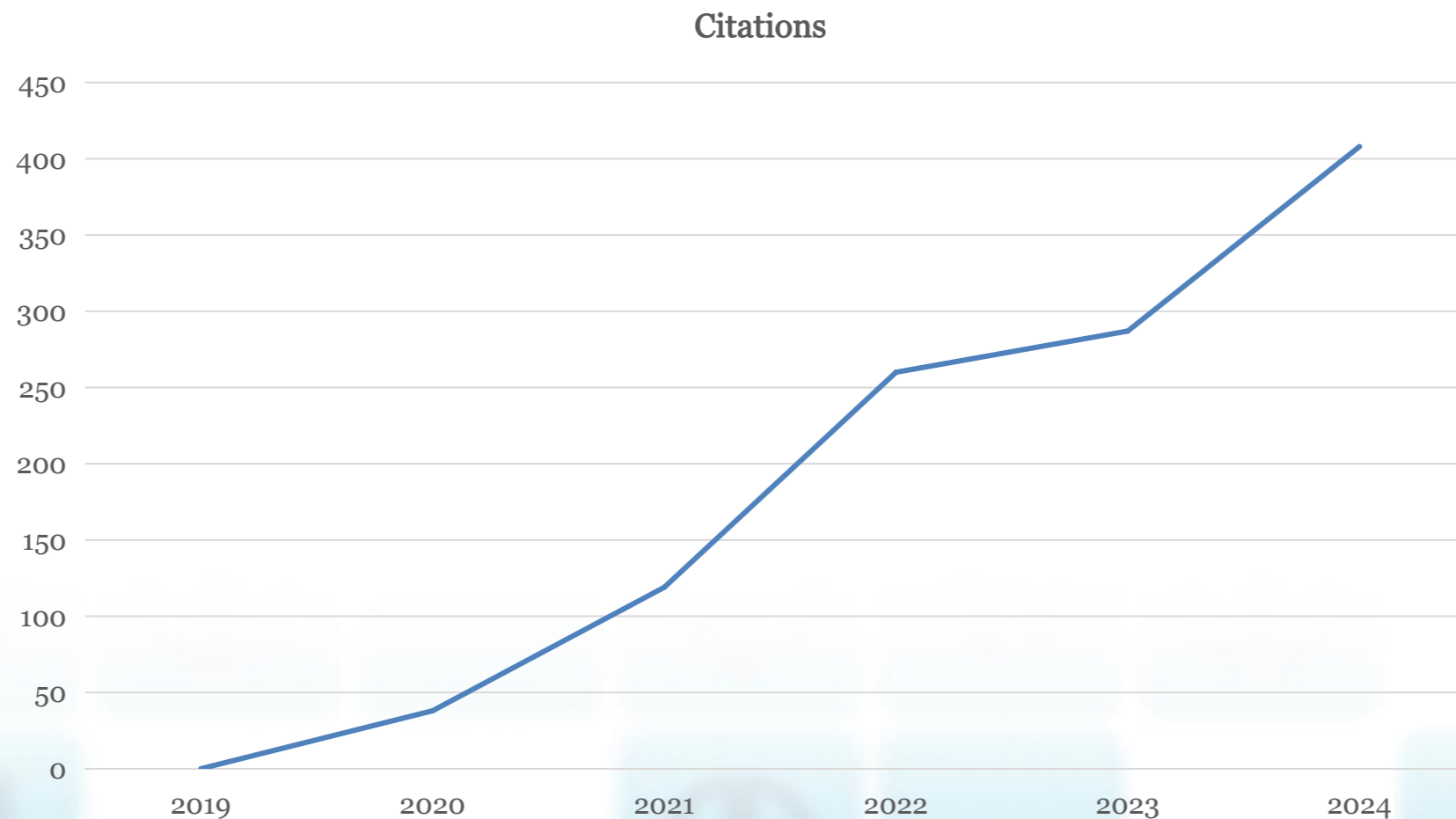

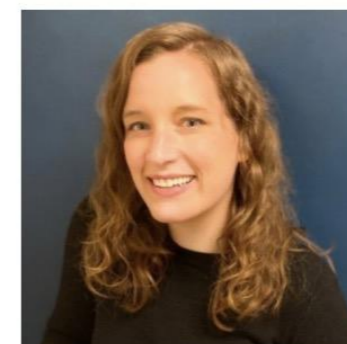


Figure 1 Ms. Erin Sullivan
