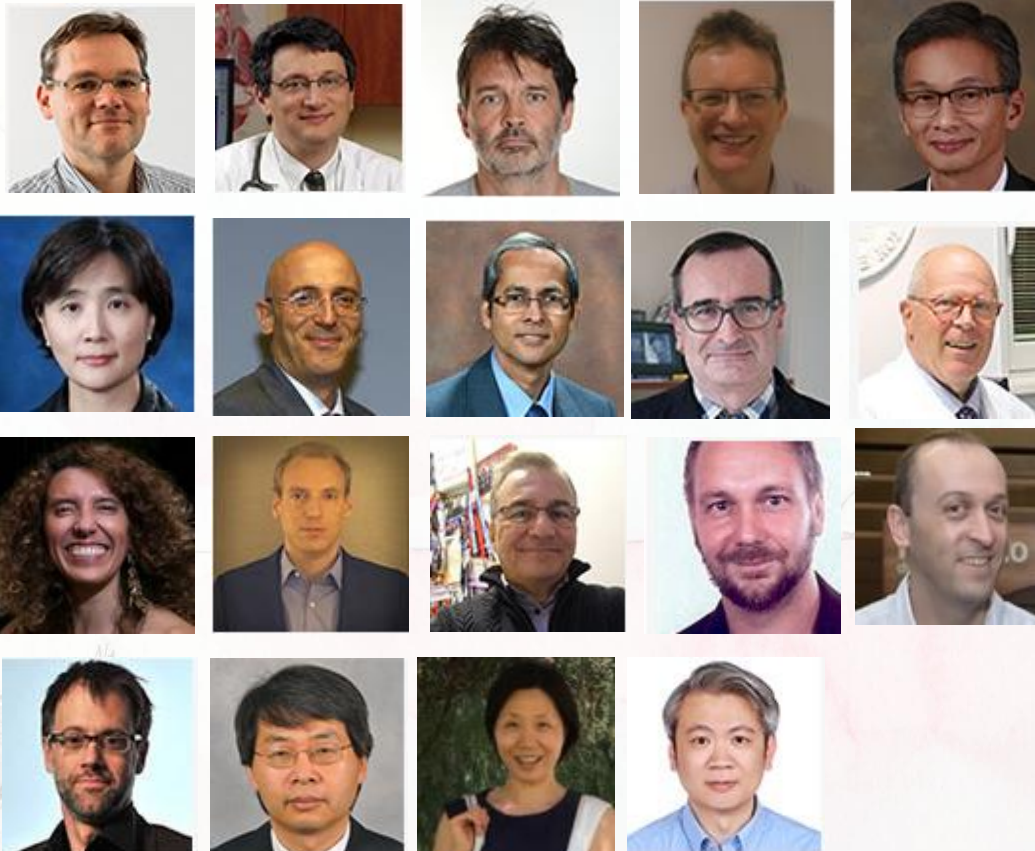

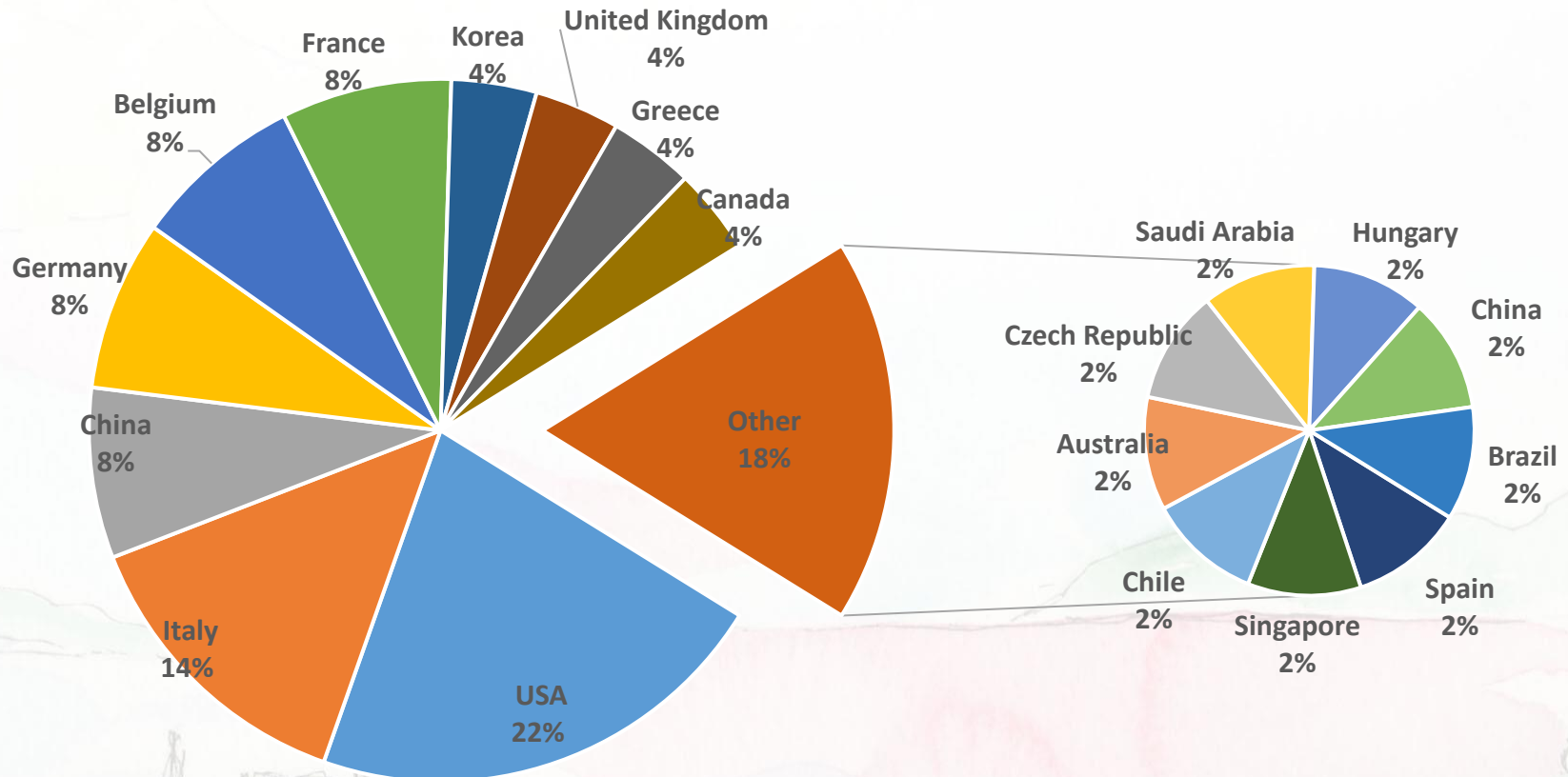

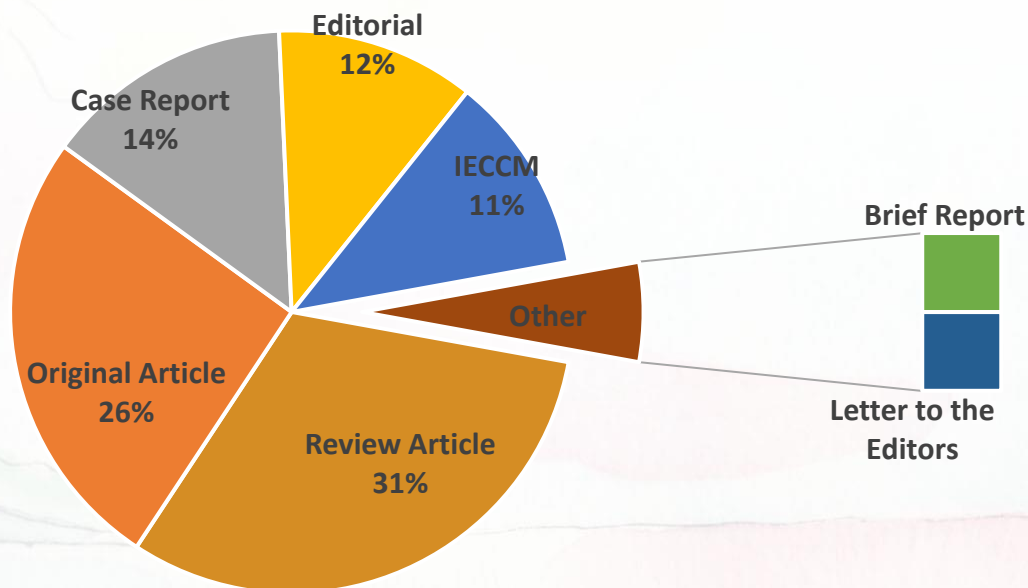
3. Distribution of Editorial Board Members

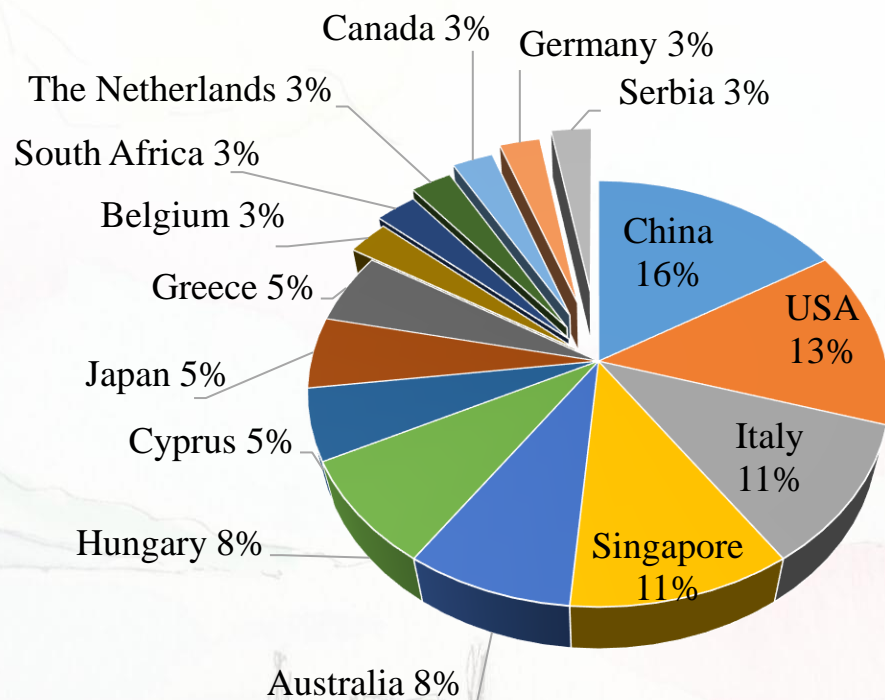
4. Diverse Types of Articles Published in 2020

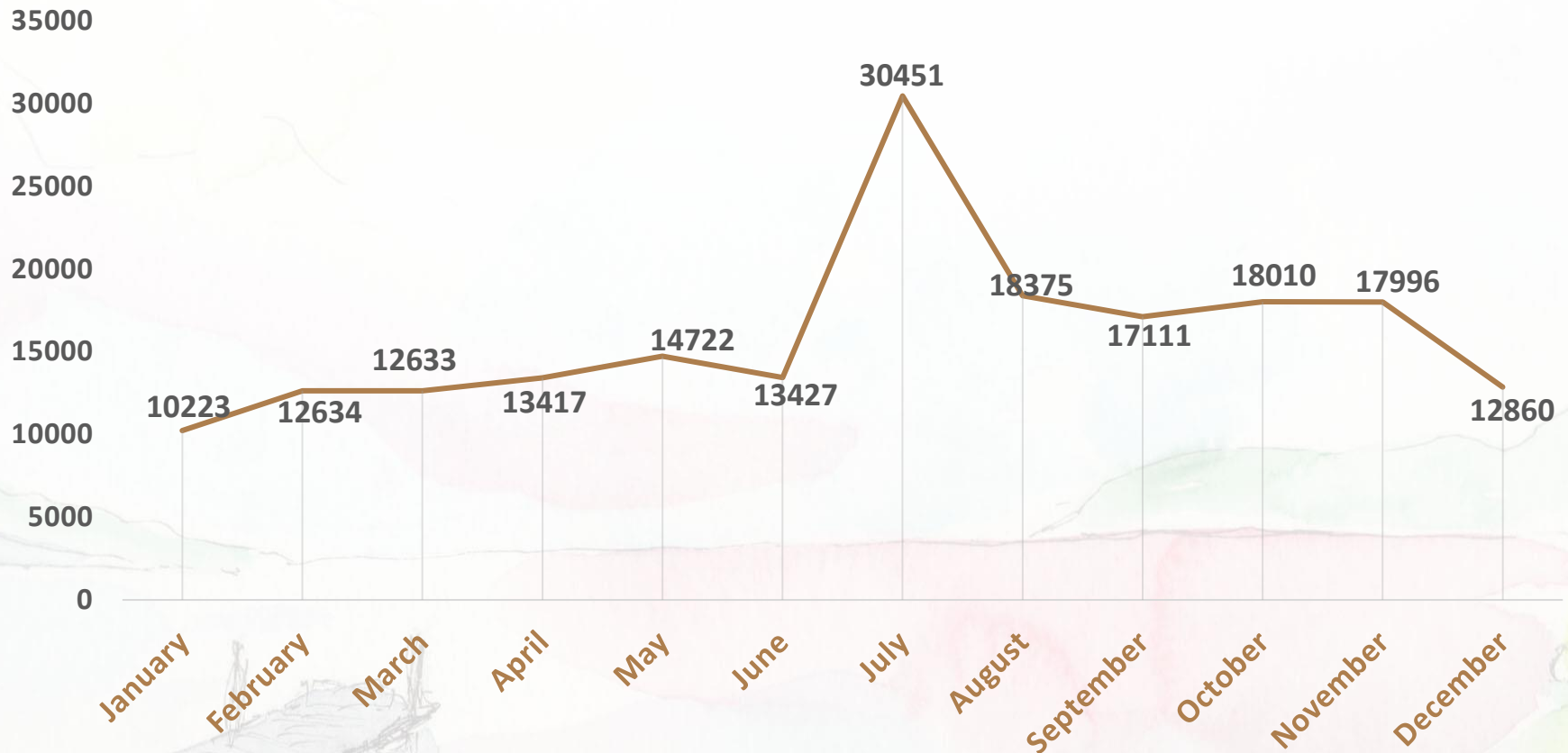

5. International Diversity of Corresponding Authors in 2020



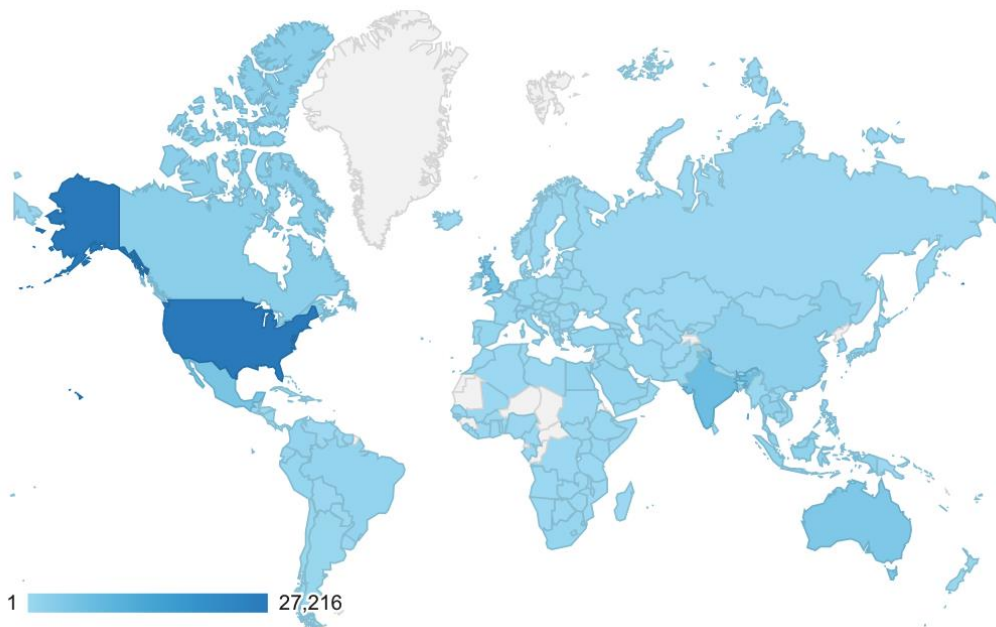
Corresponding authors of **37** articles published in 2020 come from **15** countries, **16%** of them from the China, **13%** of them from USA.
