




# **1. Basic Information**



### 4. Number of Submitted Articles and Published Articles (results by year)



### 5. Types of Articles Published in 2024




In 2024, CDT has published **109** manuscripts, among which there are **72** Original Articles and **13** Review Articles.

# 6. International Diversity of Corresponding Authors in 2024




Corresponding authors of **109** articles published in 2024 come from **25** countries with **55%** of them from China and **9%** of them from Germany.

### 7. Citations of CDT (results by year)




