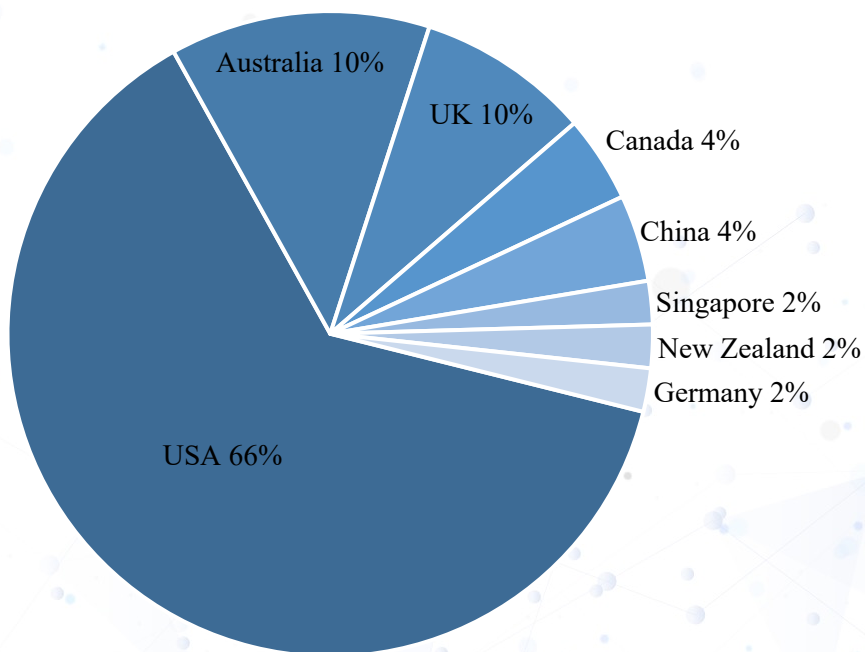

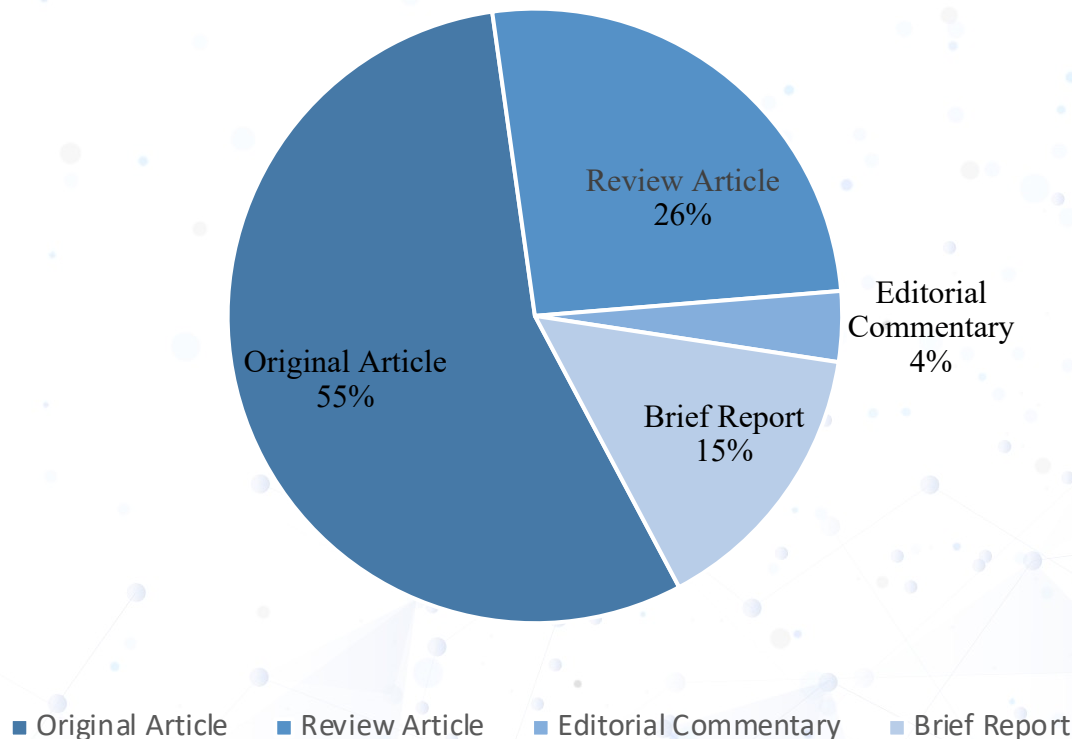
➤ Distribution of Editorial Board Members

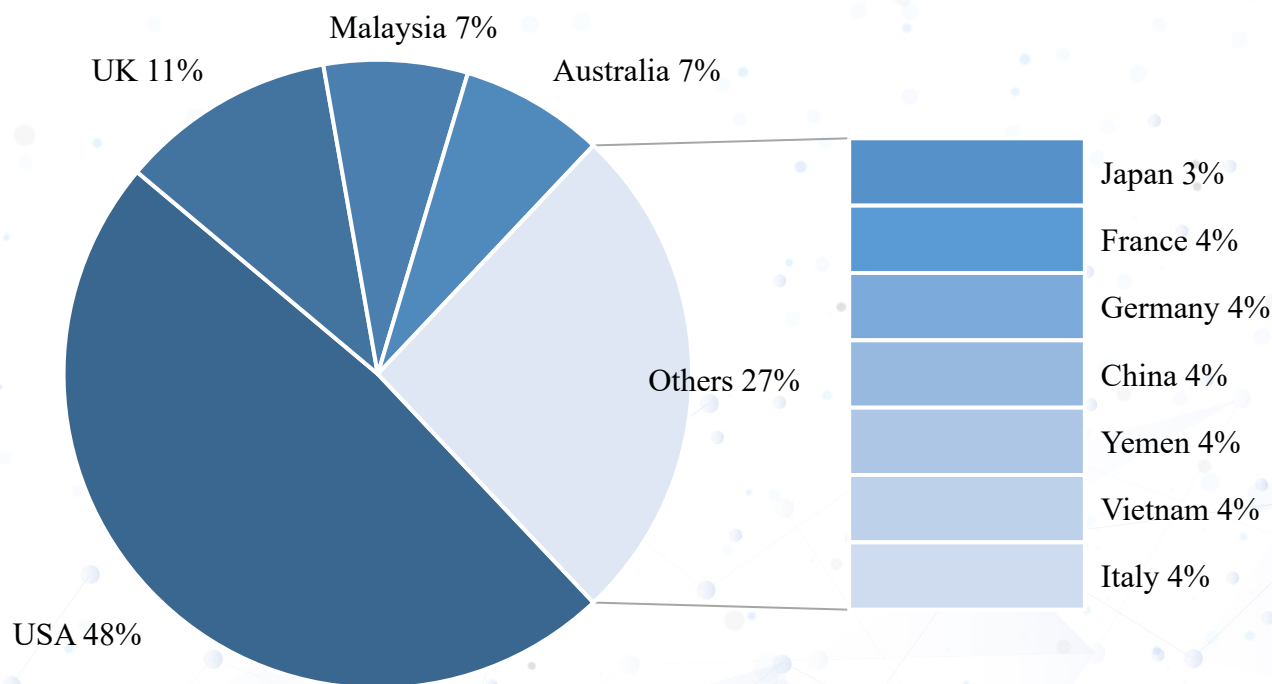

Corresponding authors of the **27** articles published in 2024 come from **11** countries with **48%** of them from the USA.

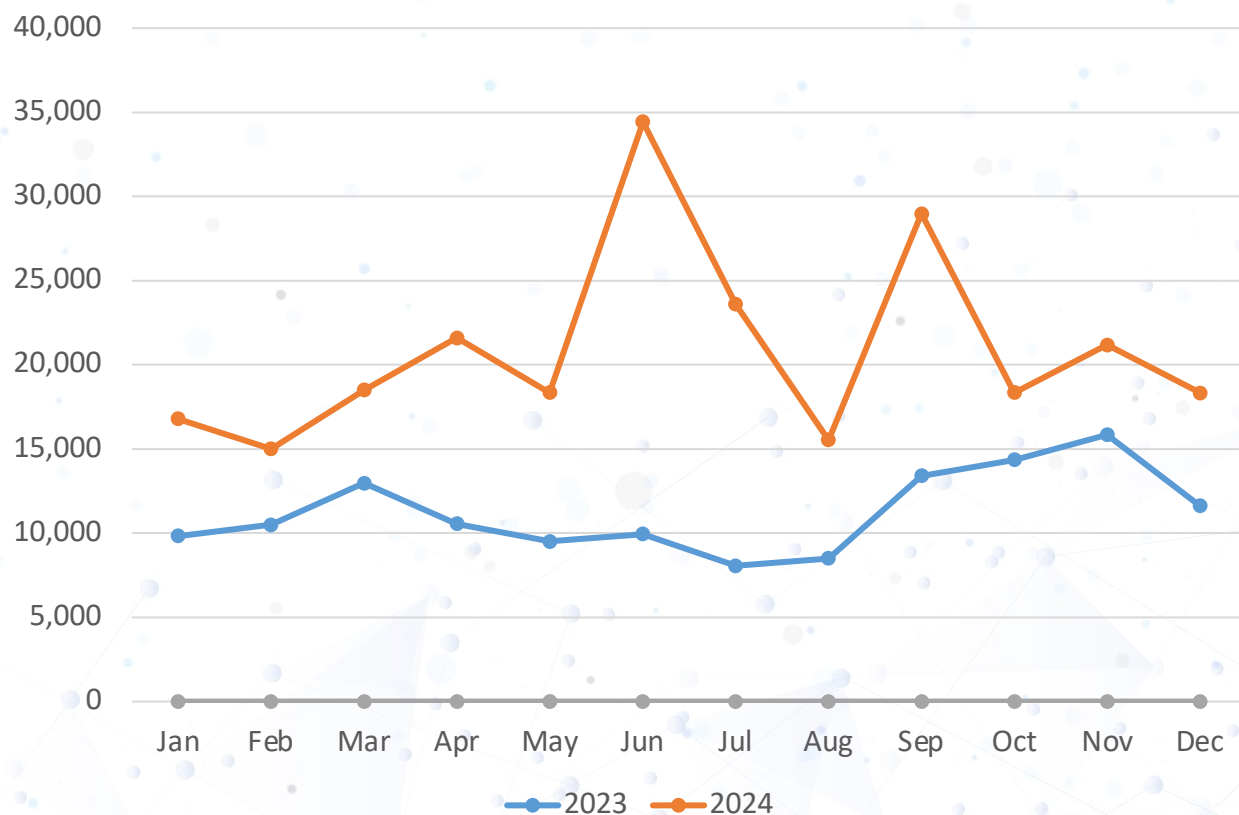

Interview

JHMHP: What drove you to pursue social work, and subsequently focus on implementation and organization science? Were there any key events that ignited your interest in the field?

Dr. Guerrero: My interest in social work was derived from social work's focus on helping the most vulnerable members of our society. I have always wanted, as a personal goal, to help those who have little, but also those who are struggling with health issues. Growing up in Mexico City, I saw a lot of need for healthcare services. There were a lot of community and family members who were affected by different types of diseases, anywhere from diabetes, cancer, addictions, and mental health issues. Since I was young, I was sensitive to those issues, which motivated me to pursue a career in the helping profession, as a clinician and later, as an organizational researcher to understand the different macro-systems, policies, service delivery, as well as the community needs of those who struggle to get needed healthcare. I have pursued questions about healthcare access for the past 25 years. I thought that implementation science and organization science would give me the tools to understand how systems of care work and how to help improve them.

Interview

JHMHP: What inspired you to venture into the field of health policy and management?

Prof. Rodwin: Since my graduate studies at the University of California, Berkeley, I was interested in the links between public health, planning, and the challenge of implementing change. As the great public leader, Rudolf Virchow, once wrote: "Medicine is a social science and politics is medicine on a large scale." I was inspired by this statement because I was always drawn more to the social sciences, in general, than to specific disciplines within this area. My undergraduate major was in Economics and I studied a bit of sociology and anthropology but my graduate studies were in public health and urban and regional planning. This field of study emphasizes a focus on real world problems related to cities and how a variety of disciplinary perspectives and methods can deepen understanding of these problems and raise the level of professional competence in addressing them.

I completed my Ph.D at Berkeley's Department of City & Regional Planning where I completed my preliminary examinations in planning theory, comparative economic systems, and health planning and policy. These are the studies that inspired me to venture into the field of health policy and management (HPAM). After completing my doctoral dissertation that resulted in my first book, *The Health Planning Predicament: France, Québec, England and the United States*, I obtained a post-doctoral fellowship with Dr. Philip R. Lee, a most inspiring mentor who had recently established the Institute for Health Policy Studies (IHPS) at the University of California, San Francisco. Previously he worked for President Lyndon Johnson as Deputy Secretary for Health in the U.S. Department of Health and Human Services. Dr. Lee believed that health policy could be improved by drawing on the perspectives and research of diverse social science disciplines. He drew a large number of social scientists, as well as public health physicians and ethicists from Stanford University and from Berkeley, to the IHPS, organized weekly seminars and frequent conferences, and shuttled back and forth to Washington DC to testify before Congressional committees on timely research relevant to pending legislation.

JHMHP: What marked the beginning?

Dr. Coughlin: When I was a student at the Health Research Center in San Diego

Dr. Coughlin: I have conducted research on health disparities throughout my professional research. For example, my doctoral dissertation at Johns Hopkins University examined Black-White differences in idiopathic dilated cardiomyopathy. I conducted collaborative epidemiologic studies on women's health and veterans' health when I worked at the Centers for Disease Control and Prevention in Atlanta, Georgia and the US Department of Veterans Affairs in Washington, DC.

Alexandra Gomes is a Research Fellow responsible for coordinating spatial analysis across a range of projects at LSE Cities. She holds strong interdisciplinary skills, and her focus spans socio-spatial comparative analysis and urban policy with an interest in sustainable mobility, health inequalities, public space, urban sensescapes, and visual communication. She has led and coordinated research projects across diverse scales and geographies, spanning Europe, the Middle East, Asia, and Africa. She is also an LSE Data Science Institute (DSI) Affiliate and an LSE Middle East Centre Associate. Dr. Gomes is currently working on a project on (De)constructing health & wellbeing through data and has co-led two projects on the impact of car-centric development in the Gulf: the Public Space in Kuwait project and the Roads as Tools for (Dis)connecting Cities and Neighbourhoods project. JHMHP: What are the most commonly encountered difficulties in academic writing?

Dr. Gomes: There are many challenges in academic writing. It is a lengthy process, and you need to follow the rules of the 'game.' The first one that I deal with constantly is time. To be able to write an academic paper, you need time. As an academic, you are often submerged in work, from conducting research to writing grant

applications or teaching and marking assignments. Time is not something that you have in abundance—especially in a research career. Then, when you finally have the time, you face the entire process of writing and getting it published. This whole process requires a combination of discipline, patience, and perseverance, where all three should go hand in hand. To make your life easier, you should choose the journal in advance to format your

Luigi Di Lorenzo is a specialist in rehabilitation medicine and in anesthesia & ICU. He has attained a PhD in Advanced Technology in Rehabilitation and a Master in Health Management. He has been the Director of the Rehabilitation Unit in Benevento, South Italy for 12 years. After a brief 8-month experience in Doha Qatar at The View Hospital, he became Chief Medical Officer at the Neuromed Group and senior research consultant at Research Hospital Neuromed, where he deals with robotic rehabilitation, spasticity and clinical translational research. From Dr. Di Lorenzo's perspective, the major challenge he encounters in academic writing is to ensure the clarity and coherence of the writing. He finds it always challenging to ensure that his writing flows logically from one point to the next. As a non-native English speaker, language barriers add an extra layer of difficulty.

Academic writing often involves evidence synthesis. In selecting the appropriate evidence for synthesis and analysis, Dr. Di Lorenzo suggests evaluating the research methodology of the sources. Reliable evidence comes from studies with sound methodologies and rigorous peer review. Moreover, authors should provide sufficient background information to help readers understand the context of the evidence, explain why the evidence is relevant and how it relates to their argument.

In addition, Dr. Di Lorenzo stresses that it is crucial for authors to disclose Conflicts of Interest (COI) in their research. The disclosure of COIs ensures transparency and maintains the integrity and trustworthiness of the research process. By disclosing COIs, researchers contribute to the credibility and trustworthiness of the scientific community.

In Dr. Mercier's view, a good academic paper significantly contributes to bridging the gap between science and policy. He says, "Academic writing is fascinating as it enables complex ideas and concepts to be conveyed in short texts."

Dr. Pai's research methods mainly include math programming, multivariate statistics, and machine learning (ML) techniques. He frequently presents at national and international conferences. Currently, he is researching several areas in healthcare, such as the Pennsylvania Rural Health Model's effect on hospital performance and the influence of health information technology on critical access hospital performance. In Dr. Pai's opinion, before reviewers agree to review a manuscript, they must ascertain they have the expertise in the field to provide constructive feedback. In addition, reviewers must ensure they have no conflict of interest with the authors (in the case of single-blind reviews) or the research under review. In addition, they must provide objective and constructive feedback such that their reviews will improve the quality of the manuscript and help authors learn more about the field. Finally, the reviewers must be empathetic in their reviews and adhere to the editor's timeline to finish the review process.

However, Dr. Pai indicates that there are several limitations in the existing peer-review process, which is time-

Dr. Austin Porter serves as an Assistant Professor at the Fay W. Boozman College of Public Health, University of Arkansas for Medical Sciences. He also holds the positions of Deputy Chief Science Officer and Deputy State Epidemiologist at the Arkansas Department of Health. Austin earned his B.S. in Biology from the University of Central Arkansas in 2005. He furthered his education with a Master's in Public Health, focusing on Epidemiology, and a Doctorate in Public Health, emphasizing Public Health Leadership, both from the University of Arkansas for Medical Sciences, completed in 2009 and 2016 respectively. With over a decade of research experience, Dr. Porter's expertise lies in injury epidemiology, health disparities research, and public health practice. His work has significantly contributed to trauma systems evaluation, the clinical management of injured patients, and understanding the disparities in their treatment.

In Dr. Porter's opinion, a constructive manuscript review offers valuable guidance to authors, ultimately enhancing their work. It is crucial for reviewers to provide detailed feedback on the points they raise, enabling authors to respond appropriately. Additionally, constructive reviews should include actionable suggestions that authors can implement to improve their manuscripts. Good reviewers elevate the quality of the paper, making it more likely to attract other high-caliber researchers to publish in the journal, thus enhancing the journal's overall quality. Conversely, a destructive manuscript review can be frustrating for authors, offering little guidance or direction for improvement. Such reviews leave researchers uncertain about how to interpret the feedback, potentially compromising the integrity of the manuscript.

The role of a peer reviewer is vital, according to Dr. Porter, for maintaining the scientific rigor and credibility of a journal. Effective reviewers not only improve individual manuscripts but also contribute to the advancement of the field by ensuring that only high-quality research is published. They help uphold ethical standards, detect potential errors, and provide an unbiased evaluation, which is essential for the growth and reputation of the scientific community.

"I chose to review for the Journal of Hospital Management and Health Policy because the manuscript title I was invited to review immediately caught my interest. The manuscript fell squarely within my area of expertise, specifically in trauma systems research. I feel a strong sense of duty to contribute to the advancement of this field by providing thorough and constructive reviews. Engaging in the peer-review process not only helps improve the quality of individual manuscripts but also promotes the overall development and recognition of trauma systems research within the academic community," says Dr. Porter.
