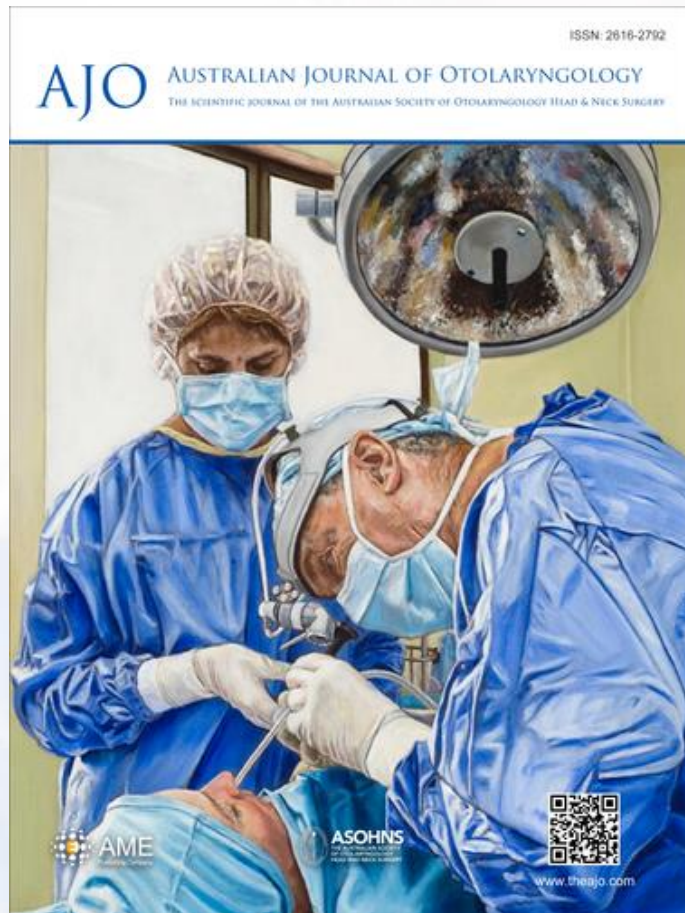

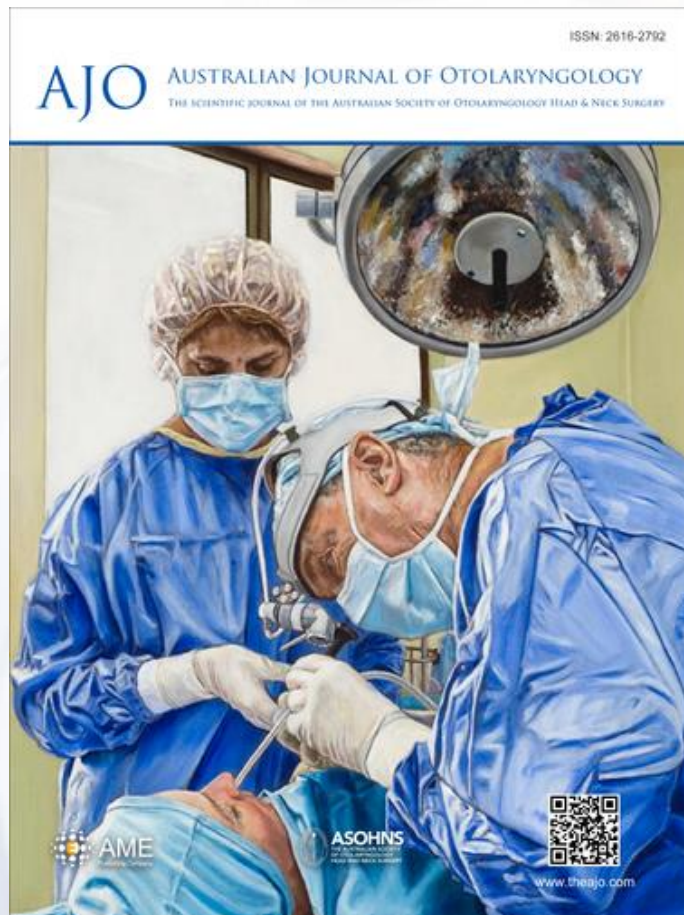

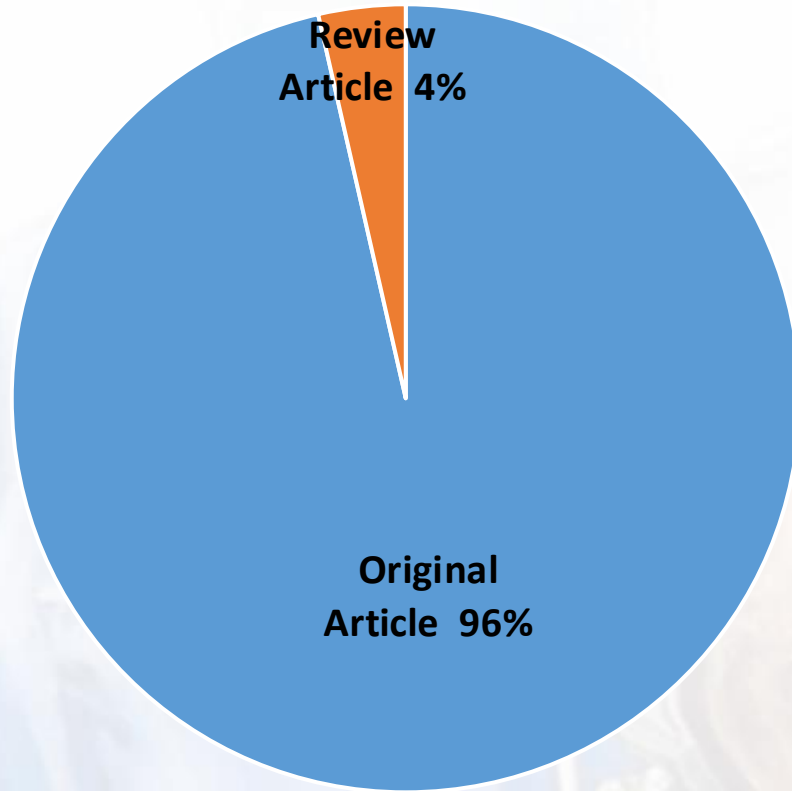

AJO has published **28 articles**, among which **27 are Original Articles** in 2023.

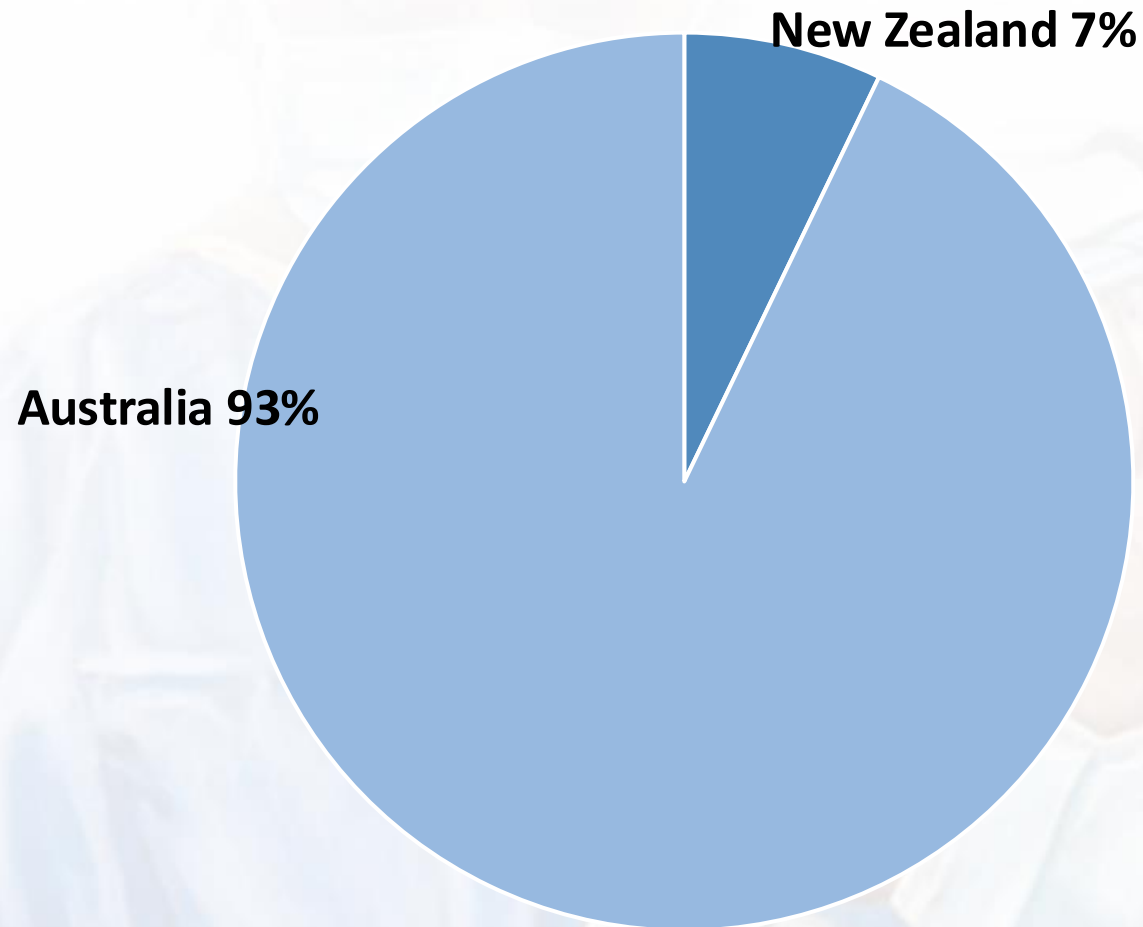

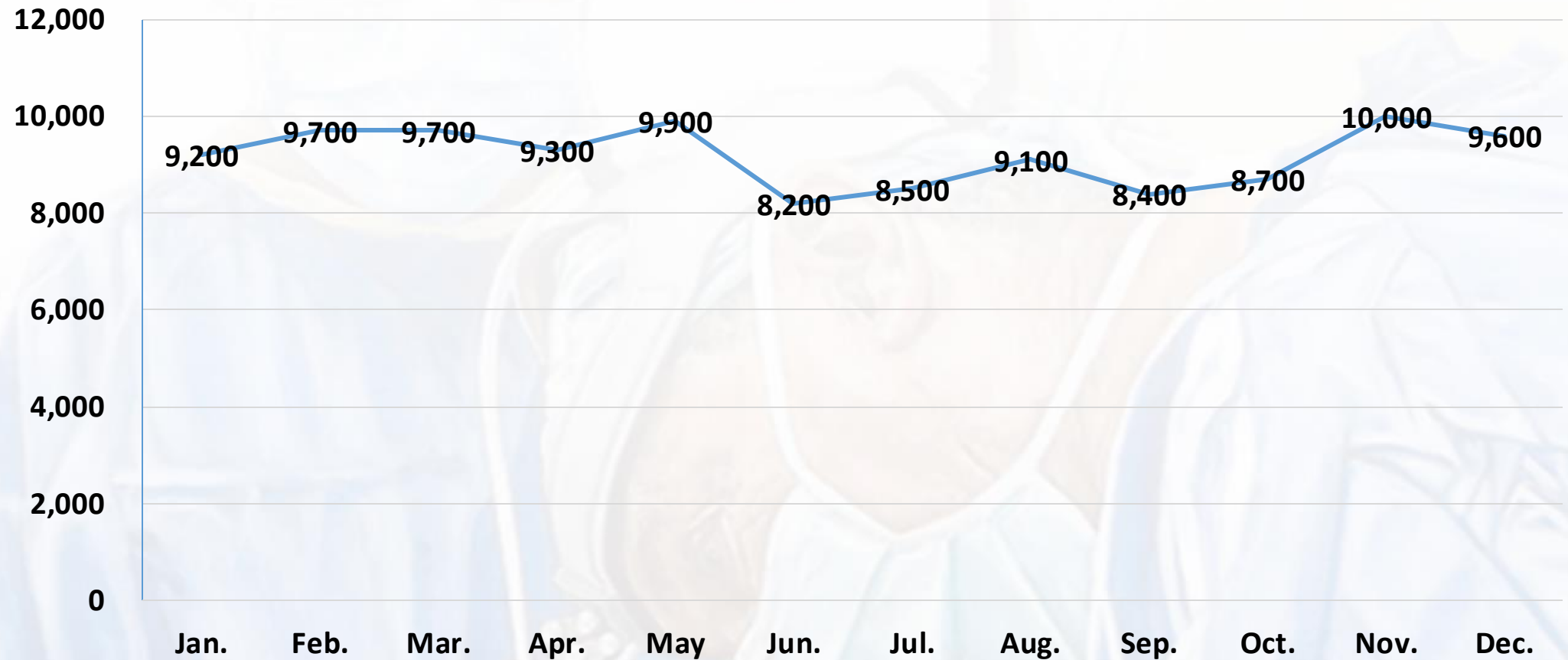

In 2023, most of the corresponding authors are from **Australia**.

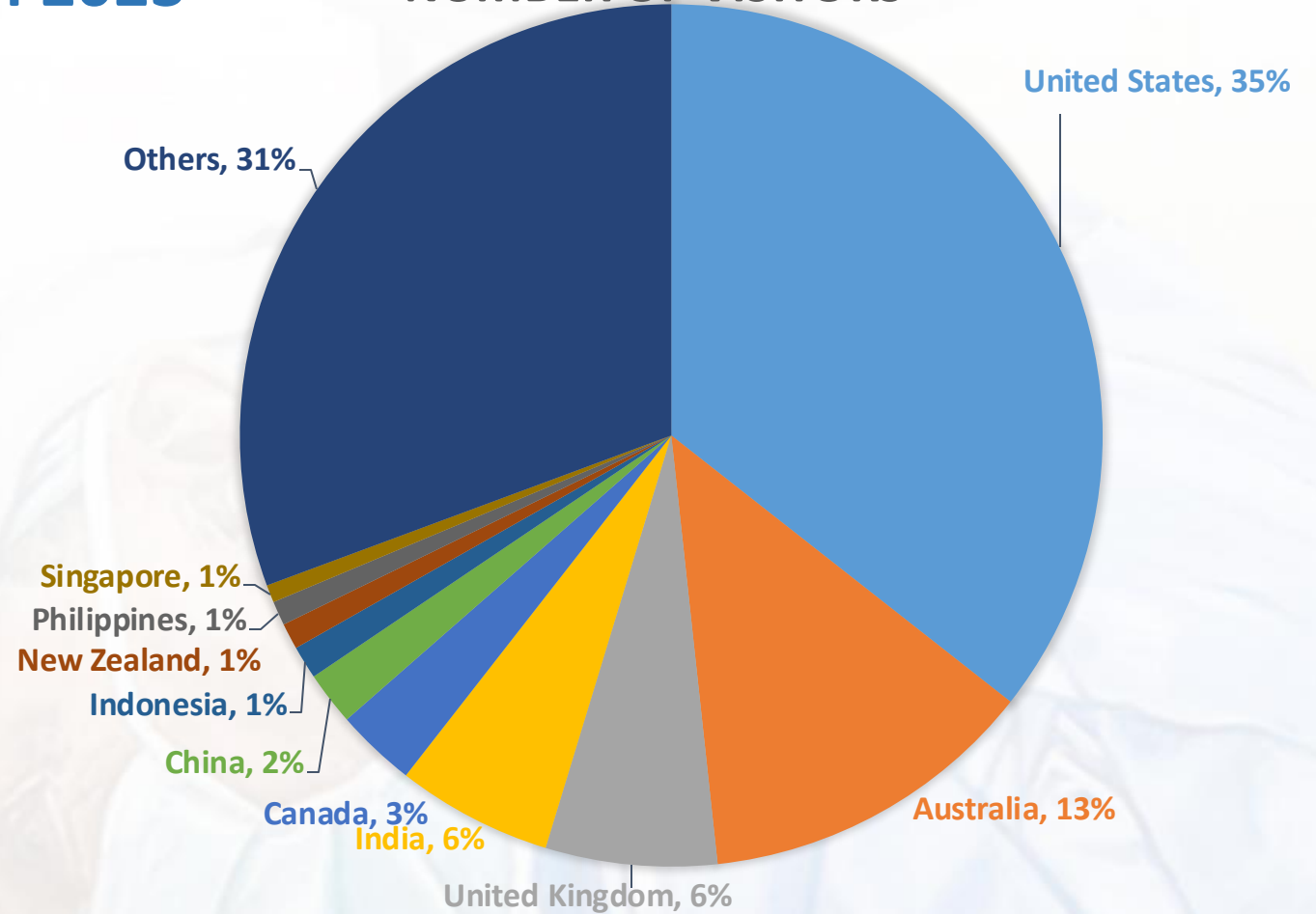
6. Pageviews of Website in 2023
